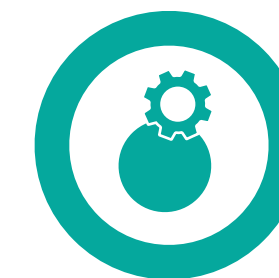

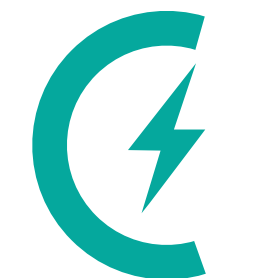

Through strategic planning and collaboration, we implemented a cohesive operating model that unified various partners and BHP operations into a streamlined project plan. Furthermore, I developed a simplified project brief that effectively communicated the program's governance structure, scope, and roadmap, ensuring alignment and clarity across stakeholders.

To enhance project operations' efficiency, I led the development of a digital strategy built on the operating model's foundation. This strategy leveraged digital technologies to optimise planning, collaboration, and governance processes within the newly established operating model, thus paving the way for improved project performance and outcomes.

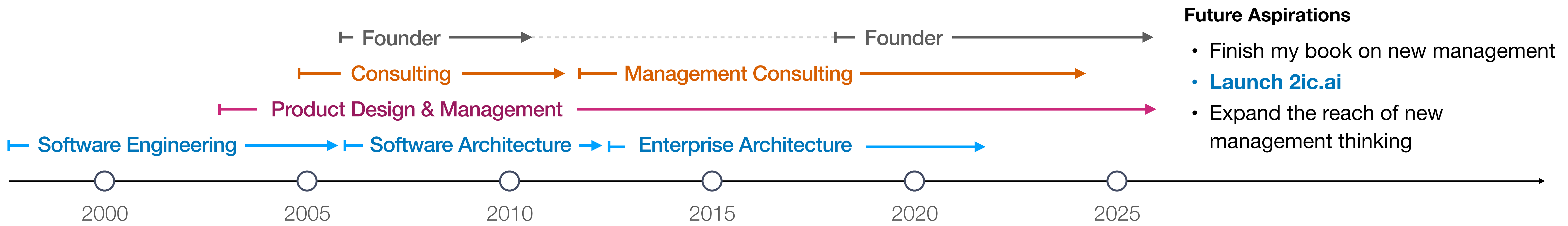
